### Mr Lorenzo Boccabella

Topics: A Workshop in Medical Negligence; A Forum on the Expert Witness;

Lorenzo Boccabella is a barrister-at-law specialising in administrative, medical negligence and migration law. In addition to his practice, he regularly lectures on migration law in Australia. He has a keen interest in the cross section between constitutional law, politics and current affairs. Lorenzo has written and lectured on comparative constitutional law, providing insights into the legal frameworks governing executive immunity and accountability.

### **Prof Melinda Jane Edwards**

Topic: Psycho-Social Safety and Integrity - The Critical Link

Professor Melinda Edwards is the Managing Director of Ethics Advisory Services. She is also Honorary Consul to the Kingdom of Bhutan. She was previously a litigator, Professor of Law, Assistant Dean and Managing Director of her own International Consultancy business before becoming the Managing Director of EAS in 2022.

She has been nationally recognised for her excellence in the design and teaching of skills-based curriculum and has taught university courses in: Equity and Trusts; Civil Procedure; Alternative Dispute Resolution; Mediation; Clinical Negligence; Business Law, Leadership and Negotiation Strategies, also publishing extensively in these areas including a number of textbooks in Equity and Trusts Law.

### **Mr Peter Fowler**

Topic: Family Law Changes from June 2025 - Family Law Amendment Act 2024

Peter Fowler is an experienced barrister based at Culwulla Chambers in Sydney, practicing primarily in family law. He was admitted as a solicitor in 1979 and practiced in private practice from 1981 to 2015, with over two decades as an Accredited Specialist in Family Law (1994–2015). Since coming to the Bar in 2015, Peter has conducted a wide range of family law matters—including mediations, interim and final hearings, and appeals—in the Federal Circuit Court, the Family Court, and the Full Court. He also appears in estate litigation, family provision claims, civil matters, and criminal hearings across various courts in NSW.

Peter's legal career spans over four decades, with a strong focus on family law, apprehended violence orders, estate disputes, and children's crime. He has presented numerous papers to fellow legal professionals on family law and estate litigation. Peter served as President of the St. George–Sutherland Law Society from 2013 to 2015 and regularly receives briefs to appear in matters across Sydney, Parramatta, Wollongong, regional NSW, and interstate.

### **Mr Stephen Lee**

### Professor Bruce.E.Bechtol, Jr

Topic: Rogue Allies The Strategic Relationship between Iran and North Korea

Bruce E. Bechtol, Jr. (Ph.D. Union Institute), is an award winning professor of political science at Angelo State University and a retired Marine. He was formerly on the faculty at the Marine Corps Command and Staff College (2005–2010) and the Air Command and Staff College (2003–2005). Dr. Bechtol served as an adjunct visiting professor at the Korea University Graduate School of International Studies (2006–2007). He was an intelligence officer at the Defense Intelligence Agency from 1997 until 2003. eventually serving as the senior analyst for Northeast Asia in the Intelligence Directorate (J2) on the Joint Staff in the Pentagon. He formerly sat on the editorial review board of the East Asian Review from 2005 to 2009 and served as editor of the Defense Intelligence Journal from 2004 to 2005. He is currently on the editorial advisory board of the Korea Observer (2011-present), the editorial board of the International Journal of Security Studies, and is on the scientific board of Global Humanities (2014present). He is the current Chairman of the Board of the International Council on Korean Studies. He is the co-author of the recent book (with Anthony N. Celso) Rogue Allies: The Strategic Partnership between Iran and North Korea (Lexington, Kentucky: University Press of Kentucky, 2025), and the author of North Korean Military Proliferation to the Middle East and Africa: Enabling Violence and Instability (University Press of Kentucky: 2018), North Korea and Regional Security in the Kim Jong-un Era: A New International Security Dilemma (Palgrave Macmillan: 2014). The Last Days of Kim Jong-II: The North Korean Threat in a Changing Era (University of Nebraska Press: 2013), Defiant Failed State: The North Korean Threat to International Security (Potomac Books: 2010), and Red Rogue: The Persistent Challenge of North Korea (Potomac Books: 2007), and he is the editor of Confronting Security Challenges on the Korean Peninsula (Marine Corps University Press: 2011) and The Quest for a Unified Korea: Strategies for the Cultural and Interagency Process (Marine Corps University Foundation: 2007). He is also the author of more than forty articles in peer-reviewed journals.

### **Amelia Evans**

Topic: Journalists in the firing line – governments and authorities fail to defend journalists.

Amelia Evans joined CPJ in December 2023. An international human rights lawyer by training, she spent more than a decade as the executive director of The Shifting Power Project (formerly known as the Institute for Multi-Stakeholder Integrity), a nonprofit human rights organization focused on rectifying power imbalances and abuses caused by corporations. Over the last 15 years, she has investigated and reported on business and human rights-related issues in a number of countries, particularly in the Central African and Asia-Pacific regions. Previously, she was a clinical supervisor at Harvard Law School's International Human Rights Clinic, and has received numerous fellowships focused on economic justice and human rights. Evans obtained her LL.M. from Harvard Law School, and LL.B. (Hons.) and B.C.A. (Economics and Finance) from Victoria University of Wellington, New Zealand. In her other life, she is a documentary filmmaker.



### **Justice Andrea Masley**

Justice Andrea Masley was elected as a Justice to the New York State Supreme Court in 2016 and assigned to the Commercial Division in 2017. She was elected to a ten-year term in the New York City Civil Court in 2007 and assigned to Family Court from 2008 to 2010.

For ten years prior to her election to the New York City Civil Court, Judge Masley was the Principal Court Attorney for Justice Charles Edward Ramos, in the Commercial Division of the New York State Supreme Court, New York County, and for Judge Louise Gans, Acting New York State Supreme Court Judge, New York County.

Judge Masley received her J.D. from Fordham University School of Law in 1991 where, in the Spring of 2005, she taught Remedies. Upon graduation, Judge Masley was a litigation associate at the firm of Dechert Price & Rhoads until 1995. Before joining the staff of the New York State Supreme Court in 1998, Judge Masley was Diversity Counsel at the City Bar Association.

Judge Masley is a member of the New York State Bar's Commercial and Federal Litigation Section, and since 1991, a member of the City Bar Association, where she currently serves on the Executive Committee. During her 2005-2008 tenure as Chair of the City Bar's Committee on State Courts of Superior Jurisdiction, which addresses issues arising in New York State Supreme Court, Appellate Terms, Appellate Divisions, Court of Claims, and Court of Appeals, the Committee drafted the form confidentiality agreement for the Commercial Division. She sat on the City Bar's Electronic Discovery Committees from 2005 to 2007, which drafted reports entitled "Manual for State Trial Courts Regarding Electronic Discovery" and "Cost-Allocation Explosion of Electronic Discovery in All Areas of Litigation Necessitates Changes in CPLR." The New York State Bar's Commercial and Federal Litigation Section awarded Judge Masley the Chair's Service Award as Chair of its PJI Committee and for her contribution to commercial practice in 2013 and 2015.

She is the author of a chapter on contract litigation in the five-volume series Practical Solutions for New York Lawyers, published by Lexis/Nexis in 2003.

Prior to her legal career, Judge Masley obtained an M.B.A. in finance and a B.A. in Economics from Rutgers University. She was the Trade Practice Specialist at the Better Business Bureau and an accountant at Bunge Corporation, a grain trading firm.

### **Lucian Simmons**

Topic: Possession and ownership in art and artifacts

Lucian Simmons is the Head of Provenance Research at the MET. He has worked at Sotheby's since 1995, most recently serving as Vice Chairman and Worldwide Head of the Restitution Department and Senior Specialist for the Impressionist and Modern Art Department. Prior to joining Sotheby's, he was a partner in the London law firm of Barlow, Lyde and Gilbert. Having studied law at the London School of Economics, he was called to the Bar in 1984 and later requalified as a Solicitor of the Supreme Court of England and Wales. He is a regular public speaker on art law, restitution, art history, and the fine and decorative arts.
